LEANING IN: A COMMITMENT TO RELIEF REBUILDING AND PLANNING FOR THE FUTURE



Despite our hopes to bid COVID farewell in 2021, in many ways, it was just the beginning. At the start of the year, we rounded out small business COVID relief programs with Greenville County, kicked off local resiliency programs with our partners in Spartanburg, and continued as a leader in the Paycheck Protection Program (PPP). In 6 months, the CW team processed and disbursed over \$6M in PPP loans to over 400 businesses across 32 counties in SC.

While continuing to support COVID relief in 2021, our team also spent time looking inward to re-evaluate products and programs to better serve communities. We added new products, increased lending in new markets, adjusted coaching to meet current demand in a post COVID world, and took a hard look at how we lean into our commitment to social justice and equity.

COVID's impact has resulted in more startups, more entrepreneurs of color, and a higher demand for affordable housing. Though South Carolina saw a peak in domestic migration, not all benefitted from the growth equally. Much of our focus was on helping businesses rebuild. With the launch of the Women's Business Center, we saw first-hand the growth of entrepreneurship, helping nearly 400 women entrepreneurs access resources.

Despite COVID, CommunityWorks experienced growth in 2021, launching several new programs and partnerships and growing assets to over \$25M, which will support expanded opportunities in 2022 to meet growing community needs.

- CW laid the groundwork to eliminate payday and predatory lending practices in SC by launching the SC Fair Lending Alliance with key statewide partners to cap loans at 36%
- CW launched several new small business loan products to meet businesses where they are, including a $new \ business \ credit \ builder \ and \ capacity \ building \ loan \ to \ support \ enhanced \ credit \ for \ small \ businesses \ and$ financial acumen as businesses rebuild
- CW launched a new affordable housing line of credit to help smaller developers participate in the development and preservation of affordable housing in key neighborhoods
- CW expanded partnerships, launching the Spartanburg Housing Fund and forged a new relationship with advocates in the Beaufort area including an investment with the Coastal Community Foundation and a partnership with Beaufort Memorial Hospital to support homebuyer assistance for their employees
- CW held a Developer Training for Faith Leaders
- CW launched an internal Equity and Inclusion Action Plan and adopted an Equity Statement to complement our vision and mission

Our team was resilient; our team was committed; and our team was instrumental in stabilizing businesses and communities, despite the sometimes-all-consuming challenges. We now look toward a different future, one of hope and opportunity. In 2022, we will be focused on our new initiatives and partnerships, while staying committed to our core mission of building financial equity for all, with a keen focus on people and communities of color.

We know that every "small win" in 2022 can "lead to a big impact." We hope you will join our journey.

CommunityWorks offers express loans, micro business loans, and small business loans up to \$250,000 to help small and micro businesses start, grow, and thrive.








LOANS BY GENDER














HOMEBUYERS BY AREAN MEDIAN INCOME




