

Beaufort Jasper Housing Trust Letter of Intent for Funding

Beaufort Jasper Housing Trust (BJHT) is seeking interested and qualified applicants to apply for financing to support affordable and workforce housing in the Beaufort Jasper County areas.

Those interested in accessing financing through the BJHT will be required to complete the following form to understand more about the project requiring financing and how it aligns with the goals of the BJHT. Interested applicants should indicate below a request for BJHT financing. Requests up to \$2M are welcome. BJHT will provide up to \$500,000. CommunityWorks can provide up to \$1.5M additionally.

Borrowers that meet the following criteria are most likely to be invited to make a full application:

- 1. At least 50% of other financing/funding in place.
- 2. All necessary development approvals are in place or near the end of the entitlement process.
- 3. Project design and cost analysis is complete.
- 4. Projects will create or preserve a significant number of units serving households making at or below 100%, with a priority of units at 60% of the area median income as outlined in BJHT Term Sheet.
- 5. The borrower has experience and a track record for delivering similar proposed projects.
